- 3. We will process the following of your personal data (if applicable to you):
- a) identification data (e.g. name, surname, address, number and series of identity cards, shareholder's company name and place of business in case of natural persons conducting business activity),
- b) contact details (e.g. address, e-mail address),
- c) data related to exercising the rights attached to shares held (e.g. name and surname of the owner, company name of the owner, address of the owner).
- 4. We have received your personal data from authorised entities, including the National Depository for Securities [Krajowy Depozyt Papierów Wartosciowych S.A.], in connection with your intention to participate in the General Meeting and exercise your voting rights, pursuant to Article 4063 § 1, 2, 3 and 5 of the Code of Commercial Companies (CCC).
- 5. We will process your personal data for the purpose of:
- a. enabling you to participate in the General Meeting [legal basis of Art. 6 sec. 1 lit. c) Regulations performance of an obligation imposed by law art. 4063 § 1, 2, 4 and 5 of the Commercial Companies Code],
- b. correct performance of tasks related to servicing natural persons who hold shares in the company [legal basis: Art. 6 sec. 1 lit. c) Regulations performance of an obligation imposed by law art. 407 § 1, 1¹ and 2 of the Commercial Companies Code],
- c. fulfillment of the information obligation [legal basis: Art. 6 sec. 1 lit. c) Regulations performance of an obligation imposed by law the Act of 29 July 2005 on public offering and conditions for introducing financial instruments to an organized trading system and on public companies],
- d. fulfillment of the information obligation [legal basis: Art. 6 sec. 1 lit. c) Regulations performance of an obligation imposed by law Regulation of the Minister of Finance of March 29, 2018. on current and periodic information published by issuers of securities and conditions for recognizing as equivalent information required by the law of a non-member state]

Data processed for the purposes referred to in point a) to d) will be processed only for the duration of the obligation to store them in relation to the implementation of the purposes set out above, in accordance with generally applicable provisions of law.

e. recording and distribution of audio recordings from the course of the General Meeting [legal basis Art. 6, clause 1, letter f) Regulations - implementation of the legitimate interest of the administrator in the form of maintaining high standards of communication with the capital market],

f. archiving to the extent necessary for the performance of legal obligations, in particular tax regulations, accounting regulations - for the period resulting from these regulations [legal basis Art. 6, clause 1, letter c) Regulations - performance of an obligation imposed by law];

g. possible court proceedings related to the rights of shareholders - for the duration of the proceedings and the limitation period for potential claims [legal basis: Art. 6, clause 1, letter. f) Regulations - - implementation of rights and obligations in the event of potential court proceedings],

h. creating analyses of the results of our business activities for internal purposes - for a period not longer than that indicated in points g) and h) [legal basis Art. 6, clause 1, letter. f) Regulations - implementation of the legitimate interest of the administrator in the form of optimization of business activity].

- 6. In connection with the processing of your personal data, you also have the following rights:
- a. The right to access personal data,
- b. The right to rectify data,
- c. The right to delete data,
- d. The right to limit the processing of personal data,
- e. The right to transfer data,
- f. Right to object.

## Right to object - additional information.

You have the right to object to our processing of your personal data at any time. You can exercise this right if the basis for processing is our legitimate interest [Art. 6 sec. 1 f) of the Regulation].

An exception to this rule will be situations where there are legitimate grounds for us to continue processing your personal data. However, these grounds must override your interests, rights and freedoms.

- 8. If you decide to exercise the above-mentioned rights, we will provide you with a response to the consideration of the request without undue delay, but not later than within one month from the date of receipt of the request.
- 9. The right to lodge a complaint with a supervisory authority. If you believe that the processing of your personal data violates the law, you have the right to lodge a complaint with the supervisory body of the President of the Personal Data Protection Office.
- 10. Information on the intention to transfer data outside the European Economic Area (EEA)

Your personal data may be transferred outside the EEA. Such a situation may take place in connection with outsourcing the performance of specific services / activities to entities based outside the EEA or processing data outside the EEA. Your personal data may be transferred only to such third countries (countries outside

the EEA) or entities in third countries for which an adequate level of data protection has been established by the decision of the European Commission, standard data protection clauses have been applied in contracts with these entities or other appropriate safeguards have been applied. referred to in a generally applicable provision.

In connection with the transfer of data outside the EEA, you may request further information about appropriate safeguards in this regard, obtain a copy of these safeguards or information about the place of their disclosure by contacting the Data Protection Officer in the manner indicated in this information.

- 11. Your personal data will not be subject to automated decision making or profiling.
- 12. The expected recipients of your personal data may be:

- b. Entities and persons authorized to receive your personal data on the basis of relevant legal provisions; (i.e. other shareholders, the Polish Financial Supervision Authority),
- c. Entities running postal or courier activities,
- d. Entities cooperating with us in handling accounting, tax and legal matters
- e. Entities operating ICT systems and providing IT services;
- f. Entities providing us with advisory, consulting, auditing and accounting services;
- g. Entities providing document archiving services;
- h. Entities providing audio-video recording services of the General Meeting
- i. Entities handling shareholder registration and voting

to the extent that it is necessary to achieve the purposes of processing your personal data.
